**URGENT NOTICE TO THE COURT REGARDING APPELLANT'S EXPEDITED MOTION**

---

**NOW COMES** Olga Teslenko, Appellant, appearing *pro se*, and submits this Urgent Notice to the Court to address the filing of Appellant's Expedited Motion to Transmit Flashdrive, Original Exhibits, and Hold Appeal in Abeyance (filed Sept. 4, 2025).

1. On September 4, 2025, Appellant filed her Expedited Motion via email. The email filing contained two attachments: (1) the Expedited Motion and its exhibits, and (2) the Proof of Service ("POS"). Appellant has attached a copy of the September 4, 2025, filing email for the Court's review.
2. Review of the docket shows that while a truncated scan of the filing email and a scan of the filing fee envelope with the enclosed POS were docketed as "Email" and "Filing Fee," the POS filed with the Motion was improperly concatenated to the end of the Motion document and docketed only as "Motion". This deviates from past practice where motions and their corresponding POS were docketed as separate documents. The POS was, in fact, a separate attachment in Appellant's original email filing.

3. Appellant confirms that the Expedited Motion was originally served on Respondent via FedEx on September 4, 2025. Due to a printer malfunction, this initial service was missing several pages. On September 5, 2025, Appellant served the omitted pages via FedEx, and Respondent received the **COMPLETE MOTION on September 8, 2025**, which completed service on Respondent. Copies of the FedEx delivery confirmations are attached
4. The Expedited Motion explicitly requests **expedited processing to be ruled upon BEFORE THE INITIAL BRIEFING DEADLINE OF SEPTEMBER 17, 2025**. The Clerk's irregular docketing should not be used to justify any delay in its consideration. The Motion, complete and served, became ripe on September 8, 2025.
5. Appellant respectfully requests that the Court review the original email filing from September 4, 2025, to confirm that the original Proof of Service was received as a separate attachment and to correct the docket entry. **Given that the Motion became ripe on September 8, 2025, Appellant urges the Court to expedite consideration of the Motion to meet the requested timeframe.**

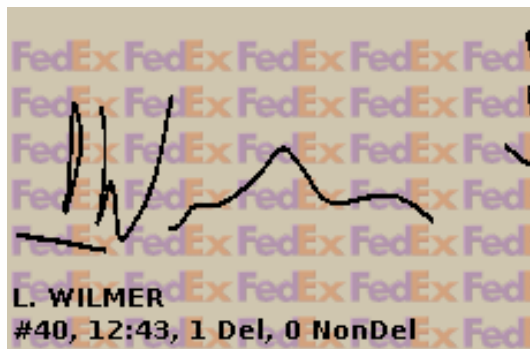
