A health update from the last letter.

Dr. Kennedy is slowly getting back to the computer but is not near full strength and is making very little progress thus far. This is a big task even when healthy when the size and volume of our case and papers/evidence far exceeds Murdaugh cases and appeals.

Dr. Kennedy is on a different, broader spectrum of antibiotics to try to stop the infection caused by prolonged stone obstruction, that is affecting her ability to feel well and is throwing up and throwing up.

Dr. Kennedy is awaiting an ultrasound to begin checking on kidney function as the fluid in her legs continues to collect even w diurectics taken, although not nearly as bad as when her kidneys were blocked causing Dr. KENNEDY both kidneys to go into hydronephrosis due to short deadlines and few pages to not default by this court mimicing the lower Unconstitutional and unconscionable actions, on our extremely meritorious claims, being criminally obstructed by your judges and other stave agents even though we have already won our case several times at the lower court w defaults and a motion for judgment as of law already, nor to mention the open criminality of the racketeering of all opposing us to hide their crimes against us w out immunity protection by law as ur judges should have been defendants also had we known sooner of the Racketwering cover up 7 plus months before we ever filed our case.

But, you can know and tell the Supreme Court that we are not going to allow any more abuse from the state on these health matters, many of which the state maliciously caused to stop us from exposing your RACKETEERING, as it is causing even more obstruction of justice now that was already obvious at the lower level and please also tell them we will not be giving up as they want us to as if we must or continue to be bullied by the very courts where justice is supposed to be received, according to the Supreme Court which is shocking they put that in writing.

We will not be bullied just because the courts and lawyers have targeted our health again, just as in the defendant underlying admissions that our very lives were targeted by your judges with the defendants help through a financial scam by McIntosh, Maddox, and Sprouse w later judges, lawyers legislators, solicitors, allianz and so forth involved. We pray that each of you choose right as this case smells very bad and you all know it and needs to b finally given to us as a complete victory as described elsewhere.
