





§16-11-110(B)


At a term of the Bamberg County Grand Jury convened on January 23, 2025, the Grand Jurors of Bamberg County present upon their oath:

That **JIMMIE LEE MCMILLAN, JR.** did, in Bamberg County, South Carolina, on or about January 2, 2025, along with another, wilfully and maliciously set fire to, burn, or cause to be burned, or did aid, counsel, or procure a burning that resulted in damage to an institutional facility, or a structure designed for human occupancy including a local or municipal building, whether the property of himself or another, to wit: setting a fire inside the Bamberg County Detention Center, all in violation of Section 16-11-110(B), of the South Carolina Code of Laws (1976), as amended.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
