MOTION TO SERVE AND FILE AN

1. The Initial Brief of Appellant and Designation of Matter were filed with this Court on June 16, 2025. The Initial Brief of Respondent and Designation of Matter were filed on September 2, 2025. The Record on Appeal is due to be filed October 2, 2025.

2. On September 15, 2025, while preparing the Record on Appeal, counsel for Appellant discovered that she and counsel for Respondent each cited to different formats of the

same transcript. The transcripts were the same in substance but the page numbering was different because one format of the transcript contained an index and the other did not.

3. On September 16, 2025, undersigned counsel contacted counsel for Respondent and notified him of the discrepancy.




