MOTION TO SETTLE AND CORRECT THE RECORD

COMES NOW the Appellants, Attia Elbadawy and Lynne Chatlos, pro se, and respectfully moves this Court pursuant to Rule 203 and Rule 210 of the South Carolina Rules of Appellate Procedure, and the inherent authority of the Court, to settle and correct the record in this matter.

1. On 09/26/2025 the Court Reporter, Ms. Bobbi Fisher, prepared and certified a transcript of proceedings held on 06/18/2025. Requested 06/28/2025, almost 3 months later transcript was produced.

2. Upon careful review, Appellants, has discovered that the transcript is materially inaccurate and/or has been altered. The transcript omits or changes critical portions of testimony and statements of opposing counsel.

3. These discrepancies prevent a fair and accurate record of the proceedings and directly impact Plaintiffs, ability to pursue post-trial motions and appeal.

4. Appellants, has preserved contemporaneous notes and can identify multiple places where the transcript is not faithful to what was actually said in Web Ex virtual hearing.

5. Appellants, respectfully asserts that under South Carolina law, the record must accurately reflect the proceedings, and any inaccuracies mishandled by the Dorchester County Court Administer must be corrected before reliance by this Court or the appellate courts.

WHEREFORE, Appellants, respectfully requests this Court to:

- (a) Order the correction and settlement of the transcript;
- (b) Direct the Court Reporter to produce a complete and accurate transcript
- (c) The Appellants, believe that changes and alterations happened intentionally.
- (d) Sanction the responsible party who violated the June 18, 2025, transcript.
- (e) Open Investigation for the transcript violation and hold the party responsible.
- (f) Grant any other relief the Court deems just and proper.


