

My name is Kong Jian Lin, Plaintiff/Appellant in case number 2024CP4601346.
Regarding the Form-7 Proof of Service issue, I respectfully state as follows:

1. Tony Lin's address has been repeatedly confirmed:
 - The Court's hearing notice dated November 19, 2024, used the address: 4034 Charlotte Hwy, Lake Wylie, SC 29720;
 - The York County Sheriff's report lists his address as 4034 Charlotte Hwy, Clover, SC 29710;
 - I personally attempted delivery and mailed documents to this address multiple times.
2. On September 5, 2025, I sent the documents via USPS Certified Mail with Return Receipt, but Tony refused to sign. After 15 days, the item was returned. USPS Manager Nakisha confirmed delivery errors, with official emails as evidence.
3. Tony has repeatedly refused to accept Court summons and filings, which constitutes intentional evasion of service.
4. It has been over three months without any scheduling or reply from the Court. I respectfully request the Court to confirm the service issue and advise the next steps.
5. Due to my limited English proficiency, I hereby apply for Chinese translation services so that I can fully understand and participate in the proceedings.
