MOTION FOR AN EXTENSION TO SERVE AND FILE
THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Charles Spencer Anderson respectfully requests a **final thirty (30) day extension, from October 2, 2025 until November 3, 2025**, in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Charles Spencer Anderson respectfully submits that extraordinary

circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Keldrekus T. Oglesby v. The State with this Court on September 12, 2025. Counsel filed the Petition for Writ of Certiorari, the Brief of Petitioner pursuant to *White v. State*, and the Appendix in the case of Euzema Maurice Austin v. The State with this Court on September 8, 2025. Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Donnell L. Washington v. The State with this Court on September 5, 2025. Counsel filed the Reply Brief of Appellant in the case of The State v. Michael Lindsay Faile with the Court of Appeals on September 2, 2025. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Jonathan Keith Bass with the Court of Appeals on August 29, 2025.


4. Counsel makes this request in good faith and not for purpose of delay.

5. On September 25, 2025, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by


Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through October 31, 2025.
