We represent the Appellant in the above-referenced appeal and are filing this in response to the Court's September 25, 2025, letter regarding the status of the transcript.

Appellant requested a copy of the transcript through Court Administration on June 25, 2025. That request was confirmed by Court Administration on June 30, 2025. No transcript was received on or before passage of the 60 days.
