Dear Ms. Secka:

I am writing to advise you that our office has not received the Record of Appeal, underlying the “Proof of Service of the Record on Appeal” filed with the Appellate Court on September 3, 2025. The Proof of Service document states, in relevant part, that you served the Record of Appeal “via electronic mail and by depositing a copy of it in the United States Mail, postage prepaid, addressed to the attorney of record....” To date, we have not received a copy by either means, although I feel we have accounted for any possible delay due to mailing. At this time, the only document in our possession is the Proof of Service, including a South Carolina Court of Appeals stamped copy of the Proof of Service mailed September 30, 2025 and received October 2, 2025.

Further, in your emails dated September 22, 2025 (transcript date clarified on September 24, 2025), you have requested a copy of the February 20, 2024 Hearing Transcript<sup>1</sup>. I am assuming that if you are requesting a copy of the transcript, you are not in possession of all of the required documents to completely compile the Record on Appeal and the Record of Appeal is incomplete.

Pursuant to Rule 10, SCRAP, Appellant is required to prepare and file the Record on Appeal. At this time, we are requesting that you provide our office with a copy of the Record on Appeal that
