I have filed a Notice of appeal in a Civil Case to the Common Pleas Clerk Of Court Berkeley Court on Sept 25, 2025.

I have mailed a copy to Trident Medical Center Live Oaks Mental Health & Wellness and Deborah Hickey to their Attorney Creasia P. Schlackter on Sept 27, 2025. The Respondent's Lawyer Creasis Schlachter responded by email that she has received all parties documents on Oct 02, 2025

I have paid the filing fee with cash on and received a receipt Oct 01, 2025 of the correct filing fee \$250.00.

I have ordered a transcript of the Berkeley County court of Judge Daniel Cobb and Thomas Rode. I was also in Probate court with Judge Crystal Smalls, and was not able to get a transcript from that court. Judge Crystal Smalls summed up to an unscheduled appearance in court on June 10, 2025. Judge Crystal Small, with the Public defender who I don't know or ever seen in my life, agreed with the order to stay in the program and medication for 12 months.

I have complied with Form 7 provided the address where I mail all parties to their Attorney, Creasia Schlachter.

We are still awaiting the final order from Judge Thomas Rode.

On a different note:

I have filed Form 1 and Form 7 to Common Pleas Berkeley County Courts. I had some documents that the courts should need. They refuse to receive the documents. Transcript is the only evidence that will be admissible in court?

The document that I sent to the parties Attorney Creasia Schlachter has picture evidence and reflects what I have written. This is my second time providing the court with proof of evidence. The clerk Sonya of Common Pleas, filed them and then put them in her draw. She gave me an order to appear in court on June 24, 2025. When I appear in court as virtual. Judge Daniel Cobb said he had nothing in the system. Attorney Creasia Schlachter was not concerned about the order for mental Health to release me that I filed on March 19, 2025.. She only wanted to talk about the Amendment to the Compensation. All these colluded with all parties. Including the police officer L. Simmons, said he can provide a dash cam. I requested one but the police department was not able to provide one. It is "Law" that the police department can use the "AI" to write their reports. But must "mark AI". False charges.

I just wanted to know if the transcript will be the only evidence?. This is my life. I am not a patient and never was.
