ON February the 11th of 2013, I Deshawn McClary was arrested in Orangeburg South Carolina for murder, upon arriving in Columbia South Carolina at the headquarters on two notch road I was advised as to who I allegedly murdered, after being read my rights the investigators explained to me what was going on. I know I didn't murder anyone so I asked for my lawyer. The Investigator sent me to a holding cell were I was to go to A.S.G.D.C, before leaving the investigator told me to contact them when I was ready to go. I later returned to the investigator's office, Deshawn McClary was told by Investigator Boland and Tanner, that if I went along and said that myself, Maurice Roberts, Demetrice James, and Vincent Nelson went to Williamsburg to commit a robbery I would be free to go after conviction, I didn't know much about the law then and I was ready to go home so I went with it, I was told I would be used as a witness and later be released. AFTER studying my case laws, I realized I was lead by investigator's Tanner & Boland to implicate myself & others in a robbery that was never planned. myself, Maurice, and Vincent left Maurice's house with the intent to go to the studio on Williamsburg. on the way there Maurice recieved a phone call, after hanging up he said Demetrice would be meeting us at

E.E Taylor, when we got to the school, Demetrice & Maurice walked off, when they returned Maurice said Demetrice was coming to the studio also. Vincent asked Maurice to hold his phone & said he would call if they said we could all come in. Minutes later my phone rang and it was Vincent, he asked to speak ~~with~~ with Maurice, Maurice walked off and when he came back he said Vincent and the owners of the studio were coming out to meet us. My phone rang again and it was a text from Vincent, it said we outside, I showed it to Maurice and he took off down the driveway. By the time Demetrice and myself made it to the bottom, Maurice and one of the guys had gotten in a scuffle, Demetrice ran to help him and they ended up fighting in the house, during all the commotion a gun shot went off, Demetrice came running out of the house followed by Maurice who lifted a gun and shot several times, I then took off running back to Maurice's house where I called a ride and left, I didn't see Maurice, Demetrice, or Vincent after that night, and I wasn't aware that someone had died until I was arrested in Orangeburg South Carolina.
