Letter to the Court of Appeals – Ms. Emily

■■■■Case Statement – English Version■■■

- 1. The court issued three summonses to the defendant, Tony Lin, but he failed to appear twice. The court should have ruled in my favor by default.
2. The court awarded only \$500 in damages, as if the life of a U.S. citizen is worth just \$500. This is unfair and unjust. Tony Lin faced no consequence.
3. My lawsuit seeks \$3,000,000 in damages due to Tony Lin's serious harm.  
Tony's threats, deceit, and pursuit have left me with no way to live safely.
  - ① Tony threatened and deceived me. My whole family fears his retaliation and dares not help me.
  - ② Tony bribed judicial and law enforcement officials, causing me harm to both my body and heart.
  - ③ Tony's conduct is a grave violation of the law and justice, yet I remain unprotected. I only ask for fairness and justice.

Tony uses any means necessary to achieve his goals, even harming officials. My fear over

two years has damaged my heart.

For my family's safety, I have lived apart for years. The police and courts failed to protect me and even blocked my restraining order request.

Now I appeal to the higher court for protection and fairness for me and my family. Please support me. Thank you!
