MOTION FOR AN EXTENSION OF TIME TO
SERVE AND FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER

Counsel for appellant respectfully requests a thirty (30) day extension, in which to serve and file the Initial Brief of Appellant and Designation of Matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed today.
2. Counsel filed the Petition for Rehearing in the case of The State v. Corey T. Busch with the Court of Appeals on October 14, 2025. Counsel filed the *Johnson* Petition for Writ of Certiorari and the Appendix in the case of Theia D. McArdle v. The State with the

Supreme Court on October 10, 2025. Counsel appeared before Judge R. Scott Sprouse in the Oconee County Court of General Sessions for a Reconstruction Hearing in the case of The State v. William D. Gunn on October 9, 2025. Counsel attended the annual South Carolina Public Defender Conference from October 6-8, 2025. Counsel filed the Petition for Writ of Certiorari pursuant to Austin v. State in the case of Terry McCarrell v. The State with the Supreme Court on September 16, 2025. Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Terry McCarrell v. The State with the Supreme Court on September 16, 2025. Counsel filed the Petition for Rehearing in the case of The State v. Travis L. Gathers with the Court of Appeals on August 21, 2025. Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Angela M. Vaughn v. The State with the Supreme Court on August 14, 2025. Counsel filed the *Anders* Brief of Appellant and the Record on Appeal in the case of The State v. Dale Smith with the Court of Appeals on July 28, 2025. Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Lamarcus D. Thompson v. The State with the Supreme Court on July 11, 2025.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that her caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.




