I returned her message, telephoning her that afternoon, and she was quite upset that I would not discuss your charges with her. Because of attorney-client privilege, I will not discuss a client's affairs with anyone else unless that client is physically present, and I explained that to her.

Additionally, it appears you filed a grievance about me with the Office of Disciplinary Counsel on October 10, 2008. As your complaint and the ensuing ODC investigation creates a conflict of interest, I must return you file to the Chief Public Defender so you may be assigned to another attorney which I will do during the month of December.

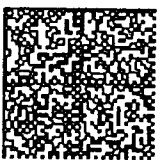

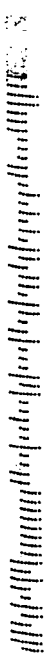
