MOTION FOR EXTENSION TO FILE APPELLANTS' INITIAL BRIEF

TO: ALL PARTIES AND THE COURT OF APPEALS:

PLEASE TAKE NOTICE that the Appellants, Coastal Conservation League and Charleston Waterkeeper, respectfully move the Court of Appeals for an extension of time for filing its initial brief and designation of matter.
