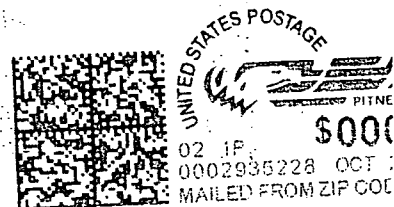

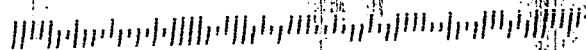

This matter is before the Court on Plaintiff and Defendant's Cross Motions for Summary Judgment and Plaintiff's Motion to Strike and Reject Appearance. Upon review of the pleadings, documents presented, and arguments of Counsel, this Court grants Defendants' Motion for Summary Judgment and denies Plaintiff's motions.

Plaintiff alleges Fraud, Civil Conspiracy, and Breach of Contract. He claims that the Defendants, whom he contracted with for services of posting bond, failed to satisfy the financial conditions of that bond. He further claims that as a direct result of the alleged failure to satisfy these conditions, he was unjustly incarcerated. In support of their Motion, Defendants presented to this Court an affidavit of Mr. Sorcia (filed in a Federal lawsuit predicated on these same facts) in which the Plaintiff acknowledges that Defendants fully satisfied all of the financial conditions of the contract. It also appears from the documents submitted that Plaintiff was under an immigration or "ICE" hold and could not be released even though Defendants posted the agreed-upon bond.

Plaintiff has not presented any evidence to create a genuine issue of material fact. As such, this Court grants Defendants' Motion for Summary Judgment.


