On September 20, 2013 counsel attended a conference hosted by the South Carolina Commission on Indigent Defense entitled Gideon at 50 in Charleston, S.C. 2013. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Terrence Black v. State in this Court on September 19, 2013. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Michael Odom v State in this Court on September 19, 2013. 

4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.


WHEREFORE, the undersigned counsel would respectfully request a **final thirty-day extension, until December 12, 2013**, in which to file the petition for writ of certiorari
