MOTION FOR AN EXTENSION TO SERVE AND FILE

Counsel for Drake Edward Campbell respectfully requests an extension of thirty (30) days in which to file the petition for writ of certiorari and accompanying appendix in this case. 3. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Davanta Johnson v. The State with the Supreme Court on November 5, 2025. Counsel filed the petition for rehearing in the case of The State v. Ronzell Bilah Olds with the Court of Appeals on October 23, 2025. Counsel filed the Anders brief of appellant, designation of matter, and record on appeal in the case of The State v. Terrele Bailey with the Court of Appeals on October 21, 2025. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Antrell Felder v. The State with the Supreme Court on October 17, 2025. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Ricorius Lee v. The State with the Supreme Court on September 17, 2025. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Nakia Johnson v. The State with the Supreme Court on September 15, 2025.

4. Counsel makes this request in good faith and not for purpose of delay.

5. Opposing counsel, the Attorney General's Office, has graciously consented to this extension request by way of the thirty-day general consent granted by email from Deputy Attorney General Donald J. Zelenka dated October 31, 2025 for all Appellate Defense extensions through November 30, 2025.

WHEREFORE, the undersigned counsel would respectfully request a thirty (30) day extension in which to serve and file the petition for writ of certiorari and appendix in this case based upon the above exigent circumstances. Counsel requests that time limits for filing the petition for writ of certiorari and appendix be held in abeyance pending a ruling on this motion.
