On Monday, October 27, 2025, a trial on the above indictments for Possession With Intent to Distribute Marijuana, Possession of a Controlled Substance, Trafficking Methamphetamine, Possession of a Weapon During the Commission of a Violent Crime, and Felon in Possession of a Firearm, commenced. The Honorable Perry H. Gravely presided. On Wednesday, October 29, 2025, a Pickens County Jury found Mr. Whetstone guilty on all counts. He was sentenced by Judge Gravely to 25 (twenty-five) years to run concurrent on all counts and a \$50,000 fine (Fifty Thousand Dollars). This appeal follows.


