MOTION TO DISMISS



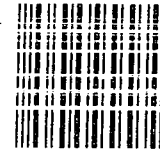

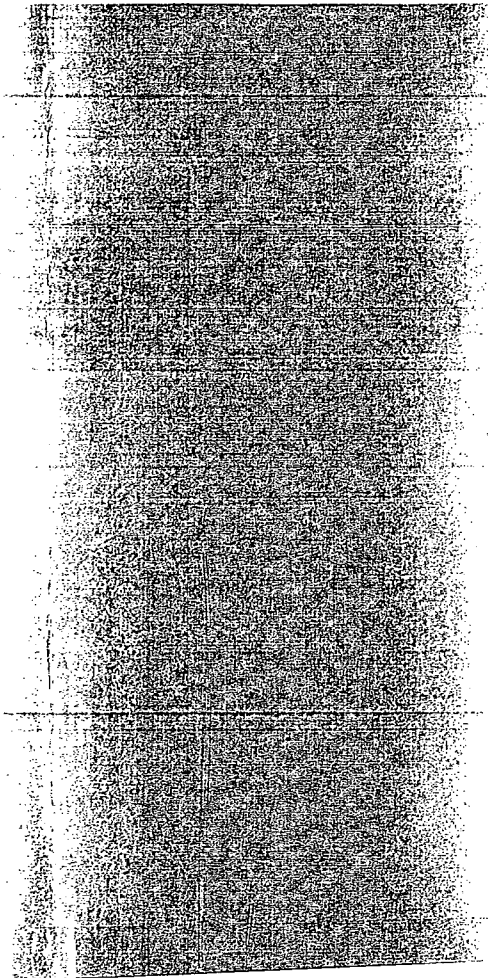
