MOTION FOR AN EXTENSION OF TIME TO

This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fourth request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed with the Court today.
2. Counsel for appellant respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions

previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

The State with the Supreme Court on October 10, 2025. Counsel appeared before Judge R. Scott Sprouse in the Oconee County Court of General Sessions for a Reconstruction Hearing in the case of The State v. William D. Gunn on October 9, 2025. Counsel attended the annual South Carolina Public Defender Conference from October 6-8, 2025. Counsel filed the Petition for Writ of Certiorari pursuant to Austin v. State in the case of Terry McCarrell v. The State with the Supreme Court on September 16, 2025. Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Terry McCarrell v. The State with the Supreme Court on September 16, 2025.




