## 1 P R O C E E D I N G S

2 THE COURT: Administration and they'll be glad  
3 to let you know how much it costs and they'll be  
4 glad to provide you with one.

5 MR. WRIGHT: Your Honor, (indiscernible) to  
6 the Court's statement -- the Charleston County  
7 Judicial Center Common Pleas Court (indiscernible)  
8 to Civil Procedure Rule 4(J) which states that this  
9 court as a foreign state and I'm on American soil.  
10 I'm an American South Carolinian. A national to  
11 the several unions of the United States. There's a  
12 distinction between citizens who are out of state  
13 and a citizen to the several states, and I Eric  
14 Holland Robert from the Wright's family which is a  
15 national, born natural, born live national to  
16 several American union states. I put a affidavit on  
17 the record. A affidavit of -- Affidavit of Fact for  
18 Judicial Notice and Complaint to Dismiss -- for due  
19 process violation official throughout a forced  
20 proceeding under great duress to the Foreign  
21 Sovereign Immunity Act. I haven't (indiscernible)  
22 immunity. I put a formal -- I put an  
23 administrative Coram Non Judice.

24 I'd like to challenge the jurisdiction of the  
25 state of South Carolina. I am an Honorable

1 Hardship veteran. I have the status of Honorable  
2 Hardship for the state of South Carolina and the  
3 United States Army. On the record -- for the  
4 record.

5 For the record, I put on the record my  
6 affidavit of Special Appearance, Judicial Notice  
7 and Writ of Coram Non Judice, and an Affidavit of  
8 Fact for Judicial Notice and Complaint to Dismiss.  
9 I have unlimited immunity under the Foreign  
10 Sovereign Immunity Act. The Courts are defined as  
11 a foreign state under the Federal Rules of Civil  
12 Procedure Rule 4(J)49 Statute 397 Series 881  
13 Convention of Rights and Duties of State, December  
14 26, 1933 qualifies to replace State statutes with  
15 international law with United Nations; I am not  
16 subject to a foreign state as a corporation. For  
17 the record I want you to ask questions concerning  
18 the errors of the Mount Pleasant Municipal Chief  
19 Justice Thomas H. Hesse. This matt -- for the  
20 record, this matter concerning: fraud, conspiracy,  
21 extortion, prosecutorial misconduct, official  
22 criminal misconduct, an act of terrorism, having an  
23 extra armed uniformed and ununiformed policemen to  
24 intimidate me as I feel threatened that my freedom  
25 of speech and my freedom from the American soil

1 will be taken away and force me in a proceeding  
2 that I did not consent to orally, or by contract.

3 For the record I did not have the  
4 opportunity to ask questions, correct the record,  
5 and if the matter at hand is a civil criminal,  
6 and I know what jurisdiction is the  
7 (indiscernible). For the record, who is the  
8 injured party, corpus delicti. Is there a small,  
9 correction, is there a small affidavit or contract  
10 on the record that I, Eric Holland Robert from the  
11 Wright family, sui juris that (indiscernible)  
12 breached and not in (indiscernible).

13 For the record is there any tangible evidence  
14 to prove the claim is valid on the record that I am  
15 a corporation, are not hearsay? For the record in  
16 the alleged accuser declare on the record that what  
17 jurisdiction they're operating from and what law to  
18 support its actions? For the record, this matter  
19 is required to be dismissed because of the alleged  
20 (indiscernible) accuser failed to disclose or  
21 withheld what jurisdiction they're operating under  
22 and the law to support it. I have Propria Persona  
23 before the Court and until the proper venue of  
24 jurisdiction is declared on the court of record the  
25 Court cannot proceed under the Foreign Sovereign

1 Immunity.

2 THE COURT: Mr. Grossman, is there anything  
3 you'd like to say in response? The return was  
4 filed on 9/18/24 which gives a full recitation of  
5 the events which took place in the magistrate's  
6 court on a bench trial and a trial in the absence  
7 on the driving without a license. Testimony was  
8 taken regarding the speeding less than 10 miles per  
9 hour and this -- this proceedings took place on  
10 June 6th of 2024. He had a sealed sentence, it was  
11 unsealed on 8-14-24 when he was present. Yes, sir?

12 MR. GROSSMAN: I see no error of law that's  
13 been presented ma'am. We request that the appeal  
14 be dismissed.

15 THE COURT: Mr. Wright, is there anything

2           that this Court is operating under.

3           THE COURT: All right. The magistrates  
4           conviction is affirmed based on the lower court  
5           record. Court can discern no errors of law. Mr.  
6           Wright is consistent fail to comply with the  
7           directives of the Court ---

8           MR. WRIGHT: Objection.
