MOTION FOR AN EXTENSION OF TIME
TO FILE THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Danny Ryant respectfully requests an extension of thirty (30) days from November 24, 2025 until December 24, 2025 in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Danny Ryant respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of

Counsel filed the Motion for Abeyance and Remand of Petitioner's Trial in the case of Shawndell Q. McClenton v. The State with the Supreme Court on November 12, 2025. Counsel filed the Notice of Appeal in the case of Trenton M. Barnes v. The State with the Supreme Court and Richland County Court on November 6, 2025. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Matthew Jamie Bryant v. The State with the Supreme Court on October 29, 2025. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Kwamaine Ross v. The State with the Supreme Court on October 24, 2025. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Michael M. Nowinski v. The State with the Supreme Court on October 22, 2025. Counsel prepared for and attended oral argument before the Court of Appeals in the matter of Jharaun Washington on October 16, 2025.


4. Counsel makes this request in good faith and not for purpose of delay.


November 30, 2025.
