MOTION FOR EXTENSION OF TIME

Pursuant to Rule 240 of the South Carolina Appellate Court Rules, Respondent respectfully requests an extension of sixty (60) days in which to serve and file Respondents' Initial Reply Brief, which is currently due on November 28, 2025.

This case was mediated unsuccessfully prior to this appeal, but the parties have agreed to attempt mediation again, which is scheduled for January 9, 2026, and the additional time requested will allow for mediation and if unsuccessful will allow Respondent's counsel to prepare and thoroughly respond to Appellant's Initial Brief. A sixty-day delay will not prejudice the rights of any of the parties. We have notified counsel below of our intent to file this motion and Counsel for Appellant has affirmatively indicated that they have no objection.

By Counsel's calculations, granting this motion would require Respondent's Initial Reply Brief to be filed no later than **January 27, 2026**.

In the alternative, Respondent's counsel seeks a 30-day extension to file Respondent's Initial Reply Brief which would make the same due before or on December 28, 2025.
