Dear Ms. Holmes,

Thank you for your email and for taking the time to review the transcript and audio of the June 18,2025 hearing before Judge Maite Murphy.

With all due respect, my co-appellant, **Lynne Chatlos**, and I must strongly disagree with the conclusion that the transcript is accurate. Based on our direct experience of the live hearing and our notes, we believe that both the transcript and the audio recording you reviewed are not a full and accurate reflection of what occurred in the courtroom. There are statements we clearly recall from the Court and from ourselves that do not appear in the transcript, and we are very concerned that the recording and/or transcript may have been altered, edited, or is otherwise incomplete.

Because of this, we are formally objecting to the accuracy of the transcript in Court of Appeals Case No. 2025-001299, and we will be notifying the Court of Appeals in writing.

In connection with that objection, we respectfully request:

1. An opportunity to **hear and review the audio recording ourselves**; and
2. A **copy of the complete, original audio recording** of the June 18,2025 hearing (in whatever format in the South Carolina Judicial Branch provides—CD, digital file, etc.).

Could you please advise:

- What is the proper procedure for obtaining a copy of the audio (for example, a written request, form, or fee), and
- Whether that request should be directed to your office, the trial court clerk, or another designated office within the Judicial Branch?

As self-represented litigants, we are simply trying to protect our rights and ensure that the Court of Appeals has a true and complete record of what occurred. We appreciate your time and any guidance you can provide on how to access and obtain that audio recording.
