Hello my name Antrell Felder  
I'm writing this letter in response  
to the 45 day for the Johnson  
vs State Petition. I am declare  
legally blind as of right now  
so I could not do the proper  
re search, but pertaining to  
Al-Shabazz Case I am entitled  
to my house arrest credit I was  
once given credit for it in my  
trial on November 18, 2011 by  
Honorable Judge King. Also I  
given two years that I have  
done at Sumter County Jail.  
My case was Reversed and Remanded  
on August 7, 2019. I was release  
back from SCDC to Sumter County  
Jail on October 14, 2019. My attorney  
Mr Charlie Johnson represented me  
on February 19, 2020. Mr Johnson  
myself and Prosecutor John P. Meadows  
enter a Plea Agreement of 22 1/2  
with me being ACCredited all the

time done on this sentence which include two years house arrest and two years that I spent in Sumter County Jail and 8 1/2 years in prison at that time. Mr Meadows and my attorney told me that the judge he could not take any time that I've already served away from me towards this sentence. I signed the plea agreement of 22 1/2 years with the knowledge of me being credited for all of my time. After I signed the plea agreement I was manipulated by my attorney and Mr Meadows that now it was up the judge to give me my time of house arrest when I was already given that time credit by Honorable Judge King. My attorney was Ineffective Assistance of Counsel, he was not prepare for a murder trial after 4 1/2 months. If you could look at the transcripts for Nov 6, 2019 you will see Mr Johnson stating to the judge that he would need at least 9 to 12 months to be properly prepared for my new trial.

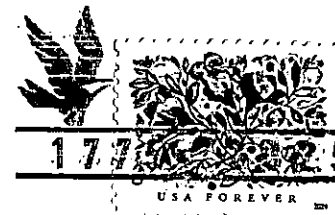
This case took place from July 19, 2008 to now 2025. They have my release date at March 9, 2029 when clearly that is incorrect. It should be 2026 or 2027 that I should be released. Mr Johnson still manipulated my family and I by stating once I get to my yard my time would kick in to be reduce down to 26-27. I also wrote classification at Kirkland, Head Quarters. My max out date moved from 2052 to 2032 to 2029, all I'm asking is that I be given my credit please because it's libing I'm doing 100% of my time instead of 85%. My charge's has been drop from murder to voluntary manslaughter on Feb 19, 2019. All I want is for my time to be calculated correctly.
