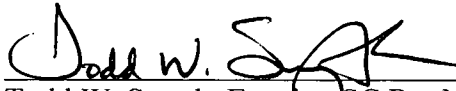
**APPELLANTS' MOTION FOR SUBSTITUTION OF COUNSEL AND 30-DAY

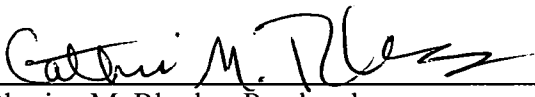
