## NOTICE OF EVIDENCE TAMPERING AND RESTORE/SUPPLEMENT RECORD; REQUEST FOR PRESERVATION ORDER, REFERRAL, AND SANCTIONS

COME NOW Plaintiffs **Attia Elbadawy** and **Lynne Chatlos** (“Plaintiffs”) and give notice that portions of the case records were removed, altered, or suppressed after filing and during the pendency of appellate proceedings. Plaintiffs move this Court for orders

- (1) restoring and/or supplementing the record;
- (2) requiring certification of a complete, unaltered record;
- (3) preserving all audit logs and metadata;
- (4) issuing a rule to show cause;
- (5) referring the matter to appropriate authorities.

### I. BACKGROUND AND FACTS

1. This action is styled **Attia Elbadawy and Lynne Chatlos v. D.R. Horton, Inc.**, Dorchester County Case No. 2024–CP–1801459 (the “459 case”).
2. Plaintiffs filed materials including exhibits and affidavits that were accepted by the lower court and timestamped.
3. On information and belief, one or more filings were *removed, truncated, or otherwise made unavailable on the public docket* after filing. Plaintiffs possess the originals and clerk stamped copies. See **Exhibit A** (authentic copy) and **Exhibit B** (before/after screenshots).
4. The alterations appear to have occurred while appellate jurisdiction was invoked and/or while preparation of the record on appeal was underway.
5. Plaintiffs promptly bring this to the attention of the Court and request immediate remedial and protective relief.

### II. LEGAL BASIS

A. **Restoring/Supplementing the Record.** Under South Carolina Appellate Court Rule **210(h)**, the appellate court may order supplementation or correction of the record and require the clerk to certify a complete record. The lower court likewise retains authority to settle and correct the record for accuracy and completeness

---

B. **Tampering with Public Records.** **S.C. Code § 16–13–410** makes it a felony to knowingly remove, alter, destroy, or conceal any public record, document, or file belonging to or filed in a public office.

---

C. **Obstruction of Justice.** Under South Carolina common law, acts that corrupt or obstruct the administration of justice—including concealment or destruction of court filings—constitute a felony offense.

---

**D. Misconduct in Office (Public Officials).** S.C. Code § 8-1-80 authorizes removal from office and criminal liability where a public officer commits willful misconduct.

E. Duties of Candor and Honesty. For attorneys, **Rule 3.3** and **Rule 8.4** of the South Carolina Rules of Professional Conduct prohibit conduct involving dishonesty, fraud, deceit, or misrepresentation and mandate candor toward the tribunal. The Court may impose sanctions under **Rule 11, SCRPC** and its inherent powers for spoliation or abuse of process.

### III. REQUESTED RELIEF

Plaintiffs respectfully request that the Court enter an Order that:

1. **Restores/Supplements the Record:** Directs the Clerk to restore any removed or truncated filings and to certify a *complete, unaltered* case file; authorizes Plaintiffs' attached copies (Exhibits A-B) to be used to reconstruct the record as needed.
2. **Preservation Order:** Commands immediate preservation of all audit logs, access logs, edit histories, server metadata, and email communications related to the docketing system for this case from *January 1, 2024 to present*, including any case management platforms ("CMS/Docket").
3. **Show Cause Hearing:** Requires any person with docket access who altered or directed alteration of filings to appear and show cause why they should not be held in contempt and sanctioned.
4. **Referral:** Refers the matter to the *Office of Disciplinary Counsel*, the *South Carolina Attorney General*, and the *State Inspector General* for investigation of potential violations of S.C. Code § 16-13-410, obstruction of justice, and misconduct in office.
5. **Sanctions/Fees:** Awards appropriate sanctions and Plaintiffs' costs/fees associated with investigating and litigating this issue.
6. **Further Relief:** Grants such other and further relief as is just and proper.

### IV. CERTIFICATION REGARDING EXHIBITS

Plaintiffs certify that Exhibits A-B attached are true and correct copies of documents previously filed and/or accepted by the lower court. Plaintiffs stand ready to provide originals for in-camera inspection.







**EMERGENCY MOTION TO INVESTIGATE MISSING PLAINTIFF EXHIBIT 5 AND  
IMPROPER ACTION ON WRIT OF SUPERSEDEAS**

COME NOW Plaintiffs **Attia Elbadawy** and **Lynne Chatlos** ("Plaintiffs"), pro se, and respectfully move this Honorable Court for an emergency investigation into the disappearance and destruction of Plaintiffs' Exhibit 5, filed on **January 17, 2025**, and for an order declaring void any rulings or denials issued by Judge **Mattie Murphy** on or after **November 2, 2025**, in violation of appellate jurisdiction.

**I. BACKGROUND AND PROCEDURAL HISTORY**

On **August 13, 2025**, the South Carolina Court of Appeals issued an order directing the Dorchester County Circuit Court to review and return Plaintiffs' exhibits so that Plaintiffs could exercise due process and forward their review to the Court of Appeals for completion of the Writ of Supersedeas (See Exhibit A). On **November 2, 2025**, Honorable Judge **Mattie Murphy**, through an email sent by **Cheyenne Herlawkirk**, informed Plaintiffs that she never saw Exhibit 4 (filed December 30, 2024) or Exhibit 5 (filed January 10, 2025). Judge **Murphy** then instructed Defendant **D.R. Horton, Inc.** to draft the Writ of Supersedeas on her behalf and to "review" Plaintiffs' exhibits, contrary to the Court of Appeals' directive that such review be performed by the Judge herself and shared with the Plaintiffs for thei...

**II. STATEMENT OF FACTS**

1. On **January 17, 2025**, at approximately **2:30 p.m.**, Plaintiffs filed Exhibit 5 (approximately 150 pages) with the Dorchester County Clerk of Court. The filing was time-stamped and accepted approximately two hours before **D.R. Horton** filed its own exhibit package at **4:45 p.m.** on the same day.

2. When reviewing the court docket in November 2025, Plaintiffs discovered that Exhibit 5 was missing entirely from the public docket and was never entered into evidence. Plaintiffs immediately visited the Clerk's Office on **November 14, 2025**, where **Rosa Lee** and her assistant confirmed that Exhibit 5 could not be found in the system.

3. After 30 minutes of searching, the clerks located a remnant of Exhibit 5 "hiding behind" the Certificate of Service for the same filing date, showing only eight pages—printed double-sided, equating to four sheets—out of the full 150-page filing.

4. The missing pages were neither restored nor explained, and no copy was provided to Judge **Murphy** for her review as directed by the Court of Appeals.

5. On **November 2, 2025**, while still purporting to review the Writ of Supersedeas, Judge **Murphy** denied three separate motions filed by Plaintiffs. Because the Court of Appeals had already assumed jurisdiction, those actions were outside her authority and therefore **null and void**.

### III. LEGAL BASIS

A. Under **Rule 210(h), SCACR**, the record on appeal must include all materials necessary for review, and the appellate court may direct supplementation or correction.

B. Under **Rule 60(b)(4), SCRPC**, an order entered without jurisdiction is void and of no effect. Once appellate jurisdiction attached, the lower court was without power to deny motions or alter the appellate record.

C. **S.C. Code § 16-13-410** criminalizes the knowing removal, alteration, destruction, or concealment of any public record, document, or file belonging to a public office.

D. The concealment or destruction of filed exhibits constitutes **obstruction of justice** under South Carolina common law.

E. These acts also implicate **misconduct in office** under **S.C. Code § 8-1-80** and potential violations of **Rules 3.3 and 8.4** of the South Carolina Rules of Professional Conduct.

### IV. REQUEST FOR IMMEDIATE RELIEF

Plaintiffs respectfully request that this Honorable Court:

1. Immediately open an **emergency investigation** into the missing Exhibit 5 and identify who removed, concealed, or destroyed the document.
2. Direct the Clerk of Court to **restore the full Exhibit 5** (approximately 150 pages) to the docket and provide certified copies to both Judge Murphy and Plaintiffs.
3. Order the preservation of all audit logs, digital access records, and system metadata between January 10, 2025, and November 14, 2025.
4. Refer this matter to the **South Carolina Attorney General** and the **Office of Disciplinary Counsel** for investigation.
5. Sanction any person responsible for the removal or destruction of evidence.
6. Declare **null and void** any rulings or denials issued by Judge Murphy after the Court of Appeals assumed jurisdiction.
7. Grant such other and further relief as may be just and proper.

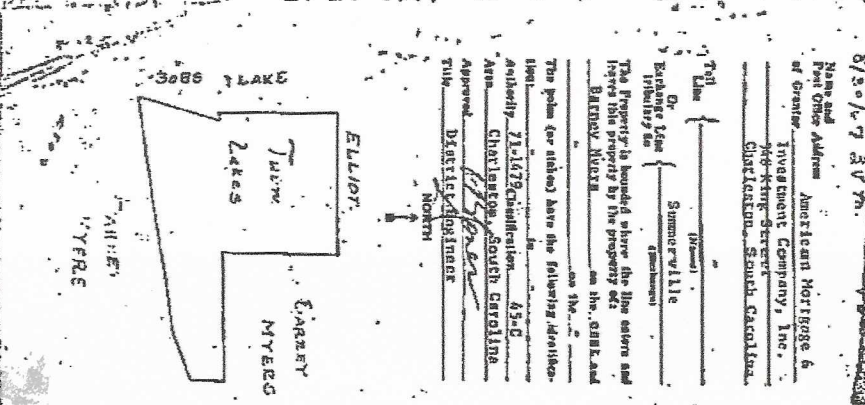
