**MOTION FOR EXTENSION OF TIME
TO FILE FINAL BRIEFS**

Pursuant to Rules 240 and 263 of the South Carolina Rules of Appellate Procedure, Respondents Gunter Heating & Air, LLC and Teddy L. Gunter (“Respondents”) hereby move for a thirty (30) day extension of time for the parties to file and serve final briefs in this matter. The current deadline is December 11, 2025, and the proposed extended deadline would be January 12, 2026.

Appellant’s Record on Appeal was served to counsel for Respondents on November 21, 2025, by hand delivery. The document consists of 428 bound, double-sided pages and does not appear to be in compliance with Rule 210, SCACR. Respondents, therefore, respectfully request an extension of thirty (30) days additional time due to the need to supplement and/or otherwise correct the record on appeal to conform to appellate rules. Counsel for Respondents has contacted Appellant regarding deficiencies in the record as served and has also requested an electronic copy

of the record be provided by Appellant due to staffing across multiple offices. Appellant has agreed to provide the electronic copy but has not yet done so.

In addition, due to the upcoming holidays, Respondents' counsel has family travel plans out-of-state on December 10th and 11th which will require him to be out of office.

Respondents believe that this relief is consistent with the interests of justice and will not work any undue prejudice upon the Appellant. This is Respondents' first extension request.

WHEREFORE, Respondents move this Honorable Court to grant an extension of thirty (30) days additional time to the parties to file and serve their respective final briefs. With the extension requested herein, the new deadline for filing and serving final briefs would be Monday, January 12, 2026, according to the undersigned's calculations.
