RULE 203 (b)(1) SCACR

Rule 203 (b)(1) SCACR when a form or other order of judgment indicates that a more full and complete order or judgment is to follow, a party need not appeal until receipt of written notice of entry of the more complete order or judgment. Therefore, the Rule directs, enters and orders default judgment and **Rule 203(b)(1) SCACR application is now law.**

Rule 203 (b)(1) SCACR, **"No action required"**. The rule acts by indicating the **"action"**; need not appeal.

On October 28, 2025 the signatories state the two elements that constitute it, "we construe", and hence, "there is no basis". Therefore, **"there is no action"** and consequently Rule 203(b)(1) SCACR indicates there is no appeal. No further action needed.

The Rule 203 (b)(1) SCACR, **"is an action"**, need not appeal. Accordingly, "there is no further action" conclusively applies automatically, as "no action needed".

"NO APPEAL NEEDED, NO ACTION REQUIRED"
