Dear Court of Appeals,


The excitement of the Christmas Holidays is filling the air. Hoping all is well.

I trust your Thanksgiving was well. My mother turned 100 years old and it is a great mark in history.


I have resorted to contacting you by US Mail, I trust that is ok. Please don't hesitate to call me at 843-244-8703 that we may discuss the cost for the transcript.
