CONSENT MOTION FOR EXTENSION OF TIME TO RESPOND TO
PETITION FOR ORIGINAL JURISDICTION

Respondent George M. Lee, III, by and through counsel, respectfully moves the Court for a twenty (20) day extension of time to file his response to Petitioners' Petition for Original Jurisdiction. In support of this Motion, Respondent states as follows:

1. Petitioners filed and served their Petition for Original Jurisdiction on December 10, 2025, making Respondent's response due on December 30, 2025.
