

On December 09, 2025 the Appellant was found Guilty by Jury Trial on Drugs / Trafficking in meth or cocaine base - 10 g or more, but less than 28 g - 3rd or sub. offense (Fel., 25Y to 30Y) (Indictment No. 2024-GS-46-05106), Weapons / Poss. weapon during violent crime, if not also sentenced to life without parole or death (Indictment No. 2024-GS-46-05106A), Drugs / Possession of less than one gram of meth. or cocaine base, 3rd or sub. Offense (Indictment No. 2024-GS-46-05109), Weapons / Possession of Firearm or Ammunition by person convicted of certain crimes -- Second Offense (Indictment No. 2024-GS-46-05111), and Drugs / Possession of cocaine, 3rd offense (Indictment No. 2024-GS-46-03104). 
