MOTION FOR AN EXTENSION OF TIME TO

AND DESIGNATION OF MATTER

Counsel for appellant respectfully requests a **fourth and final thirty (30) day extension from December 17, 2025, until January 16, 2026**, in which to serve and file the Initial Brief of Appellant and Designation of Matter in the above-referenced case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fourth request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed with the Court today.
2. Counsel for appellant respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions

previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

3. Counsel will file the Anders Brief of Appellant and accompanying Record on Appeal in the case of State v. Nathaniel Jenkins with the Court of Appeals today, December 17, 2025. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Jesse Broughton with the Court of Appeals on November 25, 2025. Counsel appeared for Oral Argument in the case of The State v. Gabriel Curry before the Court of Appeals on November 4, 2025. Counsel filed the Brief of Petitioner in the case of Jason R. Franks v. State with the Court of Appeals on October 27, 2025. Counsel filed the Brief of Respondent in the case of Eric Wells v. State with the Supreme Court on October 20, 2025. Counsel filed the Brief of Petitioner in the case of Anthony N. Briggs v. State with the Court of Appeals on October 17, 2025. Counsel filed the Petition for Rehearing in the case of The State v. Corey T. Busch with the Court of Appeals on October 14, 2025. Counsel filed the *Johnson* Petition for Writ of Certiorari and the Appendix in the case of Theia D. McArdle v. The State with the Supreme Court on October 10, 2025. Counsel appeared before Judge R. Scott Sprouse in the Oconee County Court of General Sessions for a Reconstruction Hearing in the case of The State v. William D. Gunn on October 9, 2025.






