**MOTION TO REQUEST CORRECTION**

Appellant, Jason Michael Boyle, proceeding pro se, respectfully moves the Court to note a service inconsistency in the Respondents' Final Brief and to request correction. This motion is filed to ensure procedural accuracy and consistency with the Court's own orders and service practices.


1. Jim Logan has never been removed as counsel of record in this appeal. Appellant's motion to disqualify Jim Logan was expressly denied by Order of this Court dated May 30, 2025.
2. That same Order of May 30, 2025, which clarified that criminal contempt is an offense against the State and substituted the State of South Carolina as respondent, was formally served on Jim Logan and included him on the Court's service list.
3. Subsequently, the Court issued multiple additional orders in this appeal that continued to include Jim Logan as counsel of record, including:
  - a. Order dated May 30, 2025, addressing the **motion to disqualify** and clarification of parties, which denied disqualification and included Jim Logan on the service list;
  - b. Order dated August 25, 2025, addressing the **motion to dismiss**, which included Jim Logan on the "cc" service list; and
  - c. Order dated December 2, 2025, addressing the **motion to strike**, which likewise included Jim Logan on the service list.
4. In addition to these formal orders, every item of official email correspondence initiated by the Court since May 30, 2025 has continued to include Jim Logan, consistent with his status as counsel of record.
5. Despite this consistent treatment by the Court, the Respondents' Final Brief does not include Jim Logan in its proof of service.

6. Only the Court can determine who is counsel of record entitled to service. Where the Court has consistently treated Jim Logan as counsel of record and has never entered an order removing or limiting his role, omission of his name from the proof of service creates an inconsistency in the record.
7. Appellant raises this issue not to seek sanctions, but to ensure that service requirements are being applied consistently with the Court's orders and to avoid confusion as the appeal proceeds.

Accordingly, Appellant respectfully requests that the Court direct Respondents to correct or supplement their proof of service to reflect service on all counsel of record.

This motion is filed in good faith to preserve procedural clarity and to ensure compliance with the Court's service requirements.


