## **MOTION TO EXPEDITE CONSIDERATION OF PENDING MOTIONS**

Appellant, Jason Michael Boyle, Ph.D., proceeding pro se, respectfully moves this Court to expedite consideration of the following two pending motions:

1. **Motion for Clarification Regarding Status of Counsel and Procedural Posture**

This motion seeks clarification as to whether this appeal is being treated as criminal, civil, or hybrid in nature, and whether Jim Logan remains counsel of record and in what capacity. The absence of clear guidance affects service, briefing obligations, jurisdictional posture, and Appellant's ability to meaningfully protect his rights.

2. **Motion to Request Correction**

This motion requests correction of a service inconsistency in Respondents' Final Brief, which omitted counsel whom the Court has consistently treated as counsel of record. The issue directly impacts procedural regularity and the integrity of the appellate record.

## **GROUNDS FOR EXPEDITED REVIEW**

This appeal arises from contempt proceedings that resulted in incarceration and the retroactive treatment of a civil matter as criminal, without the protections guaranteed by the United States and South Carolina Constitutions. Appellant was deprived of fundamental constitutional rights, including due process and the clarity required when liberty interests are at stake. The continued ambiguity surrounding the procedural posture of this case perpetuates those constitutional harms. Further delay causes ongoing and concrete prejudice. Appellant's professional ambitions as an academic and educator have been materially impaired by the unresolved status of this appeal, the criminal designation now attached to the case, and the uncertainty surrounding counsel and party alignment. The prolonged pendency of unresolved procedural issues also places significant strain on Appellant's family, including employment opportunities, and personal stability.

The issues raised in the pending motions are narrow, procedural, and dispositive of threshold questions that affect all remaining proceedings in this appeal. Prompt resolution will promote judicial efficiency, reduce confusion in the record, and prevent further unnecessary harm.

**RELIEF REQUESTED**

For the foregoing reasons, Appellant respectfully requests that the Court expedite consideration and ruling on the pending Motion for Clarification Regarding Status of Counsel and Procedural Posture and the Motion to Request Correction.


