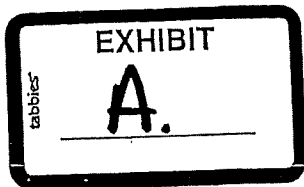

The Defendant, Taylor Reuben Adams, by way of Answer to the Amended Complaint, would allege that:

FOR A FIRST DEFENSE

1. Each and every allegation of the Amended Complaint not hereinafter admitted, qualified or explained is denied.
2. Defendant admits only so much of Paragraph 1 as alleges Plaintiff owns property on Warsaw Island. Defendant denies Plaintiff has any easement.
3. As to the allegations of Paragraph 2 of the Amended Complaint, Defendant admits he owns real property in Beaufort County, Defendant denies Plaintiff has an easement over Defendant's property.
4. Defendant admits Paragraph 3 of the Amended Complaint.
5. As to the allegations of Paragraph 4 of the Amended Complaint, Defendant would allege that the records of the Register of Deeds speak for themselves.
6. Defendant admits Paragraph 5 and 6 of the Amended Complaint.
7. As to the allegations of Paragraph 7 of the Amended Complaint, Defendant admits the Court has jurisdiction.
8. Paragraph 8 of the Amended Complaint needs no further response.
9. Defendant admits the allegations of Paragraph 9 of the Amended Complaint.
10. Defendant denies the allegations of Paragraph 10 of the Amended Complaint.

11. As to the allegations of Paragraph 11 of the Amended Complaint, Defendant denies he has trespassed on Plaintiff's property.

12. Defendant denies the allegations of Paragraph 12 of the Amended Complaint.

13. Paragraph 13 of the Amended Complaint needs no further response.

14. Defendant denies the allegation of Paragraphs 14, 15, and 16 of the Amended Complaint.

15. Paragraph 17 of the Amended Complaint needs no further response.

16. Defendant denies the allegation of Paragraphs 18 through 21 of the Amended Complaint..

17. Paragraph 22 of the Amended Complaint needs no further response.

18. Defendant denies the allegations of Paragraph 23 through 27 of the Complaint and would allege that the Court of Appeal ruling was based only upon the Record of Appeal and additional evidence will be introduced in the trial of this case.

FOR A SECOND DEFENSE

19. Each and every allegation of the First Defense is realleged as fully as if repeated verbatim herein.

20. The Plaintiff's claims are barred by the Doctrine of Res Judicata in that all issues raised the Plaintiff have been previously litigated in a Quiet Title Action in Beaufort County bearing Civil Action No.: 1989-CP-07-879.

FOR A THIRD DEFENSE

21. Each and every allegation of the First and Second Defenses is realleged as fully as if repeated verbatim herein.

22. Plaintiff's action is barred by the Defense of Unclean Hands.

FOR A FOURTH DEFENSE AND BY WAY OF COUNTERCLAIM

23. Each and every allegation of the First through Third Defenses is realleged as fully as if repeated verbatim herein.

24. The property in question is owned by the Defendant by virtue of the 1989 Quiet Title Action, the Defendant's deed and chain of title and the plats of record.

25. The Plaintiff has engaged upon a consistent pattern of trespass and harassment towards the Defendant.

26. The Plaintiff has been given multiple trespass warnings, including a warning from the Beaufort County Sheriff's Department, yet the Plaintiff continues to trespass upon the Defendant's property.

27. The Defendant prays that the Court restrain the Plaintiff from any further trespasses on his property and grant the Defendant actual and consequential damages for the consistent and continual trespass by the Plaintiff.

FOR A FIFTH DEFENSE AND BY WAY OF A SECOND COUNTERCLAIM

28. Each and every allegation of the First through Fourth Defenses is realleged as fully as if repeated verbatim herein.

29. The Defendant believes that the Plaintiff's claim violates the South Carolina Civil Frivolous Civil Procedures Sanctions Act and the Defendant, accordingly, requests that he be rewarded his reasonable attorneys' fees and costs.

FOR A SIXTH DEFENSE AND BY WAY OF A THIRD COUNTERCLAIM

30. Each and every allegation of the First through Fifth Defenses is realleged as fully as if repeated verbatim herein.

31. The Plaintiff has continuously and maliciously engaged in conduct that has interfered with Defendant's quiet enjoyment of his lawfully owned property and infringing on Defendant's privacy rights.

32. Plaintiff has, among other things, engaged in the following deliberate and malicious conduct:

a. Installing music speakers on the edge of his property pointed towards Defendant and playing loud music with purposeful intent of disturbing Defendant and his wife;

b. Installing video cameras pointing at Defendant's property to spy on Defendant and his wife with the purposeful intent of disturbing Defendant and his wife;

c. Yelling, shouting, and using continual profanity, directed at Defendant and his wife;

d. Cleaning fish on the border of the property and leaving fish refuse to harass Defendant;

e. Plaintiff has violated mutual Restraining Orders and was incarcerated by a Beaufort County Magistrate for such violations;

f. Plaintiff has encouraged others to engage in similar behavior while on Plaintiff's property; and

g. Has interfered with Defendant's attempts to market and sell his property.

33. This conduct of Plaintiff is willful, wanton, and deliberate.

34. This conduct has caused Defendant actual and consequential damages.

FOR A SEVENTH DEFENSE AND BY WAY OF A FOURTH COUNTERCLAIM

35. Each and every allegation of the First through Sixth Defenses is realleged as fully as if repeated verbatim herein.

36. The conduct of the Plaintiff constitutes a nuisance with Defendant's ownership, use, and enjoyment of his property.

37. Plaintiff has been under Court Orders to stop such conduct and he has ignored said Orders.

38. As a direct and proximate result of the nuisance, Defendant has suffered actual and consequential damages and is entitled to punitive damages.

FOR A EIGHTH DEFENSE AND BY WAY OF A FIFTH COUNTERCLAIM

39. Each and every allegation of the First through Seventh Defenses is realleged as fully as if repeated verbatim herein.

40. Defendant request that Plaintiff be temporarily and permanently enjoined from harassing Defendant and interfering in any way with Defendant's lawful quiet enjoyment of his property.

WHEREFORE, Defendant prays that Plaintiff's and the County's causes of action be dismissed, that Plaintiff be awarded all damages requested herein and/or appropriate attorney fees and costs, and for such other relief as is just and proper.

MOTION FOR SUMMARY
JUDGMENT

TO: ALL COUNSEL OF RECORD:

YOU WILL PLEASE TAKE NOTICE THAT the Intervenor, Beaufort County, will move on the tenth day after service hereof, or as soon thereafter as counsel may be heard, for an Order of this Court granting Summary Judgment to Beaufort County and declaring Beaufort County the owner of the road and boat ramp and the property which is the subject of this action. This motion is made upon the following grounds:

Subsequent to the filing of the original Summons and Complaint in this matter, the Defendant was granted partial summary judgment regarding ownership of the subject property.

That ruling of the Circuit Court was appealed in the South Carolina Court of Appeals. That upon hearing the case, the South Carolina Court of Appeals ruled that the subject property is a Beaufort County public road and is not owned by either the Plaintiff or the Defendant in this matter.

The South Carolina Court of Appeals issued that ruling in the case *Gardner vs. Adams*, Appellate Case No: 2018-001635 filed on April 27, 2022.

In its ruling, the Court of Appeals found a reasonable interpretation of the master-in-equity's 1990 order is that the "unpaved county road," "unpaved Beaufort County road," and "thirty (30) foot dirt road" are all the same road. Neither Leroy Gardner, Sr. nor John Howard owned the road; thus, neither Charles Gardner nor Adams (through his position in the Howard Property's chain of title) owns it now.

Neither the Plaintiff nor the Defendant appealed the ruling of the South Carolina Court of Appeals and, therefore, the aforementioned ruling of the Court of Appeals is the law of this case.

Beaufort County respectfully requests that this Honorable Court inquire in the matters herein and issue an Order declaring Beaufort County the owner of the roadway which is the subject of this litigation and the boat ramp located on or adjacent to the subject property.

This motion shall be based upon the statutory and common laws of the State of South Carolina, the South Carolina Rules of Civil Procedure, the pleadings, affidavits and discovery documents exchanged herein.
