being duly sworn, deposes and states as follows:

1. I am over the age of eighteen (18) and competent to make this Affidavit.

9. On April 9, 2024, I signed an Affidavit of Service that is true and accurate.



11. The timestamp on the photo (Exhibit A) was automatically generated by the app Timestamp.


12. If I did not effectuate service on an individual, I would not sign an Affidavit of Service.
