

SUPPLEMENTAL AFFIDAVIT IN SUPPORT OF MOTION FOR IN FORMA PAUPERIS

I, Sylecia McIntyre, respectfully submit this supplemental affidavit in further support of my application for In Forma Pauperis status before this Honorable Court. The following statements are made in good faith and based on my firsthand knowledge of my household and current financial circumstances:

I am the sole source of emotional, physical, and financial support for my minor dependents. There are no additional parental or grandparental supports contributing to their daily needs, housing, or general welfare.

The father of one of my daughters, who also served as a father figure to all of my dependents, passed away on March 18. His passing resulted in a material loss of support and left no financial or familial alternative. His parents are also deceased, and no relatives provide assistance.

I currently serve in multiple unpaid capacities to sustain my household. These include: patching and repairing clothing as seamstress; providing daily transportation without reimbursement; and functioning as the sole caregiver, including during illnesses or emergencies, often at the cost of lost work opportunities or delayed appointments.

My dependents have no access to gaming systems, large televisions, or costly entertainment. Our bonding time consists of shared videos on a single laptop and family board games. This reflects the limitations of our discretionary income.

Through communication with the McKinney-Vento liaison, I was advised that my household would receive bed frames for my dependents. To date, only mattresses are present. The absence of proper furnishings has added additional strain to an already taxed financial environment.

Following an automobile-related accident in September, I was required to remit nearly \$2,600 to the Magistrate Court. Around the same period, one of my daughters required therapy sessions not fully covered by Medicaid. The 60-day recovery window provided by the insurer did not allow sufficient time for full documentation and reimbursement.

This household will not receive a traditional Christmas this year. Basic needs, including utilities, food, and litigation-related costs, have taken priority over all seasonal purchases or gift-giving. At one point, a choice was made between purchasing a Christmas tree and ensuring that court obligations and household necessities were fulfilled. I prioritized the latter.

Though cash is primarily used for purchases, I can furnish recent bank statements as partial documentation of expenses. Additional receipts are being recovered where possible. Our household was approved for the Angel Tree program through Harvest Ministries this year, evidencing the material hardship and lack of disposable income.

I have worked diligently to manage and relieve the temporary hardship created by the loss of household income. I enrolled in Nail School and made considerable academic progress toward certification. However, I have been unable to complete the program due to my inability to pay a \$125 state exam fee, procure required materials valued at approximately \$250, and remit the final school exit payment of approximately \$475-\$500.

Nail School has remained the only area where financial obligations could be deferred without severe consequence. As such, I postponed completion. The consequences of not completing school do not result in eviction, legal penalties, or interference with parental rights. By contrast, if I fail to meet my fiduciary responsibilities to this Court or fail to maintain care for my dependents, the consequences are immediate and severe. My limited resources have therefore been reserved for the preservation of shelter, court compliance, and direct care for food cost and essential immediate needs my family.

I respectfully request that this Honorable Court take judicial notice of the totality of these circumstances and grant the requested In Forma Pauperis relief in light of the material hardship sustained.

I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge and belief.
