"LACK OF JURISDICTION".

RULE 203 (b)(1) SCACR

Rule 203 (b)(1) SCACR when a **form** or other order of **judgment** indicates that a more full and complete order or judgment is to **follow**, a party **need not appeal** until receipt of written notice of entry of the more **complete order or judgment**. Therefore, the Rule directs, enters and orders default judgment and **Rule 203(b)(1) SCACR application is now law**.

Rule 203 (b)(1) SCACR, **"does not allow jurisdiction"**.

The signatories on October 28, 2025 state, "we construe" , and hence, "there is no basis"; that constitutes a due process violation. Accordingly there is **"no jurisdiction"**. Rule 203 (b)(1) SCACR deprives the court of procedural jurisdiction.

Therefore, Rule 240 (i) applies automatically. Finally the maximum reasoning indicates the Default Judgment stands eternal. Rule 203 (b)(1) SCACR, when a [form/follow]; need not appeal.
