Dear Clerk Kitchings and Chief Judge Williams,

This correspondence follows my recent certified mail submission, (Certified Receipt # 70200090000096652134 and Return Receipt # 95909402348672754064), received by your office on December 15, 2025 at 11:34 a.m., which included verified equity notices protesting the imposition of public jurisdiction over this matter involving private trust res.

This supplemental submission now respectfully includes additional equity notices and instruments in light of recent attempts by opposing counsel to obtain writs of ejectment through the public Magistrate Court. These filings are presented in the interest of conscience, and are properly addressed to the chambers of equity within this honorable Court.

As Steward Trustee of the STCJ NETWORK REVOCABLE LIVING TRUST, I now tender into the court's private record the following lawful trust instruments:

- **Certification of Trust** (filed and recorded with Clarendon County)
- **Trust Transfer Grant Deed** (conveying trust res into the STCJ Network Trust)
- **Exclusive Trustee Objection to Writ of Ejectment and Possession**
- **Notice of Pending Equity Appeal and Stay of Dispossession**
- **Demand for Proof of Standing in Equity – Opposing Counsel**
- **Exclusive Equity Notice of Possession and Use of Trust Res**
- **Trust Minutes Entries Corresponding to Each Instrument**

These instruments form the foundational evidence of the trust estate and substantiate my standing to proceed in exclusive equity. I respectfully request that your office to lodge these documents on the private side of the court's record, remove this matter from the public docket, and ensure all further actions are confined to equity chambers, not the civil division.

As this submission involves matters already placed before the equity chambers, I respectfully

request that you forward these documents to the Honorable Chief Judge H. Bruce Williams for equitable consideration and entry into the private equity record.

Please be advised that the continued public listing of this trust matter constitutes an ongoing trespass upon the private trust res and violates long-standing maxims of exclusive equity:

- **Exclusive equity will not allow a wrong without a remedy**
- **Exclusive equity regards as done that which ought to have been done**
- **Exclusive equity sees substance rather than form**
- **Exclusive equity acts in personam, not in controversy**

In exclusive equity, no party may be compelled to suffer unjust harm for the administrative failure or misunderstanding of others. The trust has made repeated good-faith efforts to lodge these instruments in exclusive equity. Any rejection or failure to act now, particularly in light of full notice and supporting documents, would constitute willful fiduciary breach under exclusive equity.
