

**MEMORANDA IN SUPPORT OF NOTICE OF INTENT TO APPEAL**


Upon request of this Court, in response to the letter from the Court on November 18, 2013, the Appellant by way of trial counsel files this motion in support of his Notice of Intent to Appeal.

1. Where the Appellant was originally convicted on April 23, 2008, counsel filed and served a timely Motion to Reconsider on April 25, 2008. Said motion was filed with the Aiken County Clerk of Court and served upon the 2<sup>nd</sup> Circuit Solicitor's office in accordance with Court rules.
2. No hearing for the Appellant's motion to reconsider was ever docketed by the Solicitor's office.
3. Upon further inquiry with the Trial Judge, the Hon. Judge Hill issued a written letter stating he was denying the Applicants motion to reconsider on October 23, 2013. Said letter was received by trial counsel on October 28, 2013 and was forwarded to the Appellant requesting confirmation if he would like to file an appeal.
4. Response was received from the Appellant that he wished for an appeal to be filed and one was filed with this Court on November 7, 2013, within 10 days of receipt of the final Order denying the Appellants motion to Reconsider.

5. Where the Appellant has been incarcerated continuously for more than 5 years, he is indigent and a affidavit of indigence has been obtained and this file has been forwarded to the South Carolina Office of Indigent Defense for further representation of Mr. Hall.


