I was h^d for "twenty five months at J Reuben detention center in Conway, SC without a trial and finally took a plea just plea to the offer did not state any things. I had plead not guilty but told it be another year to trial, I am now trying to appeal, 42 1983 or appeal the conditions or monitor and other conditions not there. I lived in Myrtle Beach, SC for 5 years in an apartment before this at 408 76**' Avenue N APT 1 Myrtle Beach, SC 29572. I lived a few blocks from the'beach, leased, paid rent monthly, other costs or paid for everything I had from working ail these legal jobs for last almost 40 years I had worked at Scotchman 1274 21@* Avenue N for 2 years 8 months as a Ft sales associate. The store was across from Broadway at the Beach and a few blocks down is Pelican ball park. I have worked extra shifts worked at other stores, sometimes double shifts. The last few months I am scheduled fortyeight hours week 6 days eight hours each but averaged 50 to 54 hours week" I am on camera in almost all these places working all these years as a good team member. I been exercising and joined an exercise club in 2014 because getting to out shape wanted to fix my out of shape condition before I got old and been joiniri'g exercising club since. There still another issue that came about this was for employment. I was hired 10/2025 as an sales associate for the holidays but background report changed that or lie came through. This because of the plea agreement I did not want to take but twentyfive months or another year waiting without due process in Conway General sessions court I took the plea. I took time served plea without stating a word I had sent pleadings, denied the allegations, not guilty losing everything already I took the time served plea because of my economic disadvantage. The employer put it on the computer job site I was no longer being considered for the job and this first time since being employed that ever received I got a message on the company hiring website where stated applications my onboarding or hiring was being cancelled. The forty years of employment I have never received a message stating my hiring was being cancelled I had trained and worked the job as you know I was upset for sure emotionally and mentally. I lost 1000s of dollar worth of completed paid in my apartment the 1000s put down on my FORD FOCUS 2013 THAT FINANCED ONLY FOR A FEW MONTHS. I lost my apartment and my career job or had no plans to leave

I was suddenly grabbed and touched strangely on chests body arms with bare hands

not telling me whom they were. There was no identity on no uniform they smelled some, were dressed in plain clothes and did not seem to do anything officers usually do so I think they were lay persons. A uniform officer came there. A few minutes later. The guy in back of me also threw my bag grabbing and ripping it out my hand threw my open food bag toward the ocean this lady not with them brought my bag back she sat the bag away from me stating on the dry beach in sand she stated it was in the ocean He also threatened to harm me saying he rip off my legs he was in back of me pulling on my legs backwards toward him while pulling my arms forward the

opposite direction like a tug war with my body this ail cause me to have a loss of balance they both tried to throw my partly disabled ass to ground but [did not want to get hurt of hurt my legs which also would've started crying I immediately complied to the uniform officer whom arrived: came to the beach. The uniform officer asked me to turn around away from her so I immediately turned around. I think she shown me cuffs the attention was clear think something let me immediately calmly was cuffed and she walked me to the police car. I placed in back seat there for a minute then taken to Myrtle Beach police station arraigned 07/15/2023 and straight to J Reuben Detention Center in Conway, SC no attorney present for about a month and half no public defender no way to get money or no one I knew to contact I like to consult explain what the truth really is from me. I did not get any papers or view court papers and the last time I was in court it was based on lay person's opinion was opinion. I still don't have information or no anything got nothing about the case that begin 07/15/2023. I never received any papers at all from courts Conway or Myrtle Beach Criminal court except the denied in writing allegations to myself even at present 10/17/2025 or the public defenders or only attorneys I had in the case for 07/15/23. I ask now 10/17/2025 and had prior asked for consultation from attorneys trying find an attorney to represent or, assistance. I have a letter from a month or so from my female sister where I grew up. I have lived outside the state of Maryland since 1991 or left for some time in 1990 where I lived in San Francisco, CA as resident for about twenty-five years. I have talked to her in Baltimore, MD we been getting along good she, I are both getting there in age but she is almost ten years older than I. I had been through stuff or been a victim so many times with their imagination crap, lies or victimized-from strange acting persons Many times in the past including the many reasons that I left Baltimore, Md was cause their extreme flipping or acting strange on drugs, or alcohol horrible nightmares or imaginations not true bizarre stuff untrue stuff sometimes of or about persons in neighborhood or community. The things we were supposedly to be doing but not that is same now things supposed to be doing. I was a child then dependent someone seemed to be selling or using and distributing drugs I was child scared had nothing. I pretty much still am becoming dependent again without place to stay work or money from earning legally or any of the things I owned including my clothing gone. I left Baltimore, MD for good in 1991. know socially I feel going towards being less independent and dependent now. I have been living 35 years till now on own that why I stand now is victim, we watch view other victims some from drug use, viewed the others dealing drugs using to get profits, somewhat they have and lot of domestic violence and violence. They drove their cars then reckless fast when younger then run away from police and jumped out just smashed hit kicked sometimes welding things as sticks or bats hurt someone or battery to someone again then or I am so very tired of them. I now have same stories same punk bullies I did not do that and sure person whom the story was on news here I did not ever be near or do anything too. I was quiet about

my sister to now cause threats started to be stated by them they would hurt or something be done to her. Some of these threats again came when I was in Phoenix, Az where I called the police or 9 number unsure if tape about battery to I. They would watch me they made threats toward my family when there living or residing as a leased resident and tenant, recent in Phoenix, AZ some which viewed similar to ones who;victim izect me iii;Baitimdre;!/ID ^

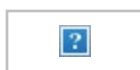
