**APPELLANT TNT AND MORE, INC.’S
MOTION FOR EXTENSION OF TIME**

Pursuant to Rules 240 and 263(b), SCACR, Appellant TNT and More, Inc. moves this
Court for an extension of time for Appellants to file their Initial Briefs and Designation of the
Record in this matter.

In support of this motion, TNT sates as follows:

1. TNT filed its notice of appeal in this matter on November 12, 2025. Because the
trial transcript had already been prepared, TNT’s Initial Brief and Designation of the Record was
due December 12, 2025. *See* Rule 208(a)(1), SCACR.

2. On November 24, 2025, Appellant Timothy D. Kettner moved for a 30-day

extension of time for both Appellants to serve their Initial Briefs and Designation of the Record. This Court granted the motion the following day, making Appellants' briefs and record designations due January 12, 2026.

3. TNT requests an additional 30 days for Appellants to file and serve their Initial Briefs and Designation of the Record. If the Court grants this request, Appellants' briefs and designations will be due February 11, 2026.

4. Good cause exists for this request because of the complexity of the matter, the length of the record, the recent holidays, and other professional commitments of counsel, including a Petition for Writ of Certiorari also due to be filed and served on January 12.

5. This request is made in good faith and not for purposes of delay. Respondents and Kettner will not be prejudiced by this extension.

6. TNT conferred with Respondents and Kettner regarding this extension, and all of them consent to it.

Appellant TNT and More, Inc. therefore requests that the Court grant this motion and extend the time for filing Appellants' Initial Briefs and Designation of the Record until February 11, 2026.
