I, Ken Moorehead appeal the action in Conway, Myrtle Beach criminal court the harassment or intimidation that begin on 07/15/2023. I ask for an extension of time for filing the appeal. The reasonable reason the appeal was because the appeal was not received by the SC Court of Appeals. I think if I remember right, I sent the appeal by mail and on time to the SC court of appeals I had mailed the pencil appeal before being release in 08/2025 from J Reuben detention center giving to person at desk in the jail mail. I was told on 10/31/2025 that the appeal was still not received by calling the clerk of the court. I sent an appeal a few weeks later by US postal mail from 505 North Kings Highway after the confusing of everything being somewhat better being instantly home with all the loss of my whole life. I sent appeals in 08/25, and weeks later not received by the SC appeals court. I APPEAL NOT HAVING DUE PROCESS and denying my rights to due process OR TRIAL, OR denying US CONSTITUTION Amendment six, The SC constitution right think 24—and the speedy trial right. I have claimed this right in the Conway Criminal court repeatedly by jail mail self-addressed stamped envelopes, or copy of the filed pleadings begin in 10/23 or repeatedly claiming by filed pleadings. I claimed the right to US constitution Amendment six, SC constitution, and the speedy trial act or right. I had sent stare decisis of decisions one was 70 days in 1970s and newer rights about prejudice to either party. The public defender Scott Grau stein no longer representing case closed and don't want to represent with this appeal or want to file this appeal PRO SE. I never had a trial or due process I was told by the public defender end of July 2025 I would have to wait another year for trial. This was told to me after serving being locked up one year and one month that the unnecessary, unfair delay that it would be another year for trial or due process if I did not take the plea, also told I get the maximum sentence if did not take the plea. I was harassed, intimidated by all this since 07/15/2023. I was a hostage similar to a POW with no rights to surrender or suffer, continue suffer and now suffer more after being release like I was not even a United States citizen or in the United States. I had very bad conditions since arriving at J Reuben detention center nothing to do at all, worse than being a toddler, nothing to do all day, repeatedly same television shows when out or none, endless waiting for any relief or anything to happen, bad food which repeatedly weekly, daily with nothing else, no snacks, hungry, no coffee, strange rules, punishment hit before some do something to stop even being threatened sometimes taken with being one with only one hour later after this stalking be safe move bad weird violent persons near acting crazy before even in there or same cell. I was battery or assaulted a few times even after telling they being other way first no response to threats.

I had a good life of low-income working person, I had rented apartments, places to live almost thirty-five years, recently for few months in 07 23 a financed vehicle a SC DMV registered vehicle never had a car before, and thousands of legally obtained things from working legal jobs inside my apartment. I was told by the owner who lives in Georgia that all my things were throughout including my clothes that someone had taken them out I asked several times did not know and my car had been towed but Car Max stated they did not get car back or have possession of it in 10/25. I got a view of everyone else in apartments when reach placed to view where lived someone else was living there, everyone I knew still had jobs, I been walking since 08/09/2025 being embarrassed, with nothing, homeless at first, I did not know where to go or have clothes but new directions in Myrtle Beach for emergency night has been a blessing or lots of relief. I lost my entire life with no fairness no trial did not get to defend myself or defense, or even freedom of speech I wrote letters to persons in government with no response like lowest form of life or didn't exist my loyal good working US citizen I definitely felt dislike or confusion I mean I always thought I was person I always gave trust but seemed to be absolutely none. I loved and cared where seemed non back, I was even told by Scotchman that I could not be reemployed. By store manager at 3207 highway 17 that Human resource stated I was not able to be employed. I am nothing and everyone else as slave or peasant they live with persons who care, families, apartments, jobs and some very expensive vehicles one I never considered or could ever afford eating food I have never afforded or like welcome to 1800s or some early time. I stayed in new directions but lot persons they dray chips, and wrong one I slept outside with no place to go no one seems remember or say hi lots days before this they talked to me. I stood in the rain, been out all night in the rain, cold I asked places everywhere including 211 or united way there are none. This all is completely unfair, unjust denying rights, due process and denying the Us constitution seems denying a right to even be a United States citizen. This like the British government from an old century took over we were not free, tax us very high a peasant, or slave and did not exist.
