Hi Shelby,

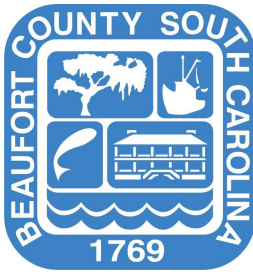
