### **Marco Bates, # 249552 – TYRCI-0688-24**

In your grievance, you claim that you are entitled to prevailing wage backpay for work at Lee Correctional as a Material Handling Equipment Operator from October 1998 through May 2001. Our records show that the work program in which you participated was not a Prison Industries Enhancement Program job ("PIE" job) subject to the prevailing wage statute. The work you performed at Lee Correctional was a traditional/service job that is covered under a different statute. Accordingly, you were not entitled to the prevailing wage for your service work, and your grievance is therefore denied.

5. If you are not satisfied with the Warden's decision, you may appeal to the appropriate responsible official within five (5) days of your receipt of the Warden's decision, by placing your Step 2 appeal form in the Grievance Box at your institution.

I am employed by the South Carolina Department of Corrections (SCDC) as the Director of Support Services and Industries. I have been in this position since 2015 and have worked for SCDC since 2015.

My duties include but are not limited to managing and overseeing the Industries Program.


I am aware that inmate Marco Bates is seeking to be paid pursuant to the former prevailing wage statute, *i.e.*, SC Code Ann. § 24-3-430 (d), for his participation at the furniture and upholstery plant at McCormick Correctional Institution (“MCCI”) in 1998 to 2001.

Inmate Marcus never participated in a Prison Industries Enhancement Certification Program (“PIE” or “PIECP”) at MCCI. MCCI did not have a PIECP during the times subject to this matter.


The furniture and upholstery plant was set up as a prison industries traditional and service project. SCDC was essentially its own partner for this program. There was not a private industry sponsor for this program. Inmates in the program were paid service wages if they were working on a service project. Inmates were not paid if they were working on a traditional project. As such, the Summary of PI Payroll Hours, included in the Supplemental Record, shows when

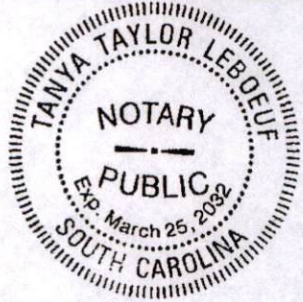
inmate Bates was paid service wages at various time from 1998 through June 2001. Inmates assigned to the program were furniture assemblers.

Accordingly, inmate Bates did not work for a designated PIE or PIECP while at MCCI.


