MOTION TO REINSTATE APPEAL (RULE 260, SCACR)

COMES NOW the Appellant, **Aaron E. Quinzy**, pro se, and respectfully moves this Court to reinstate his appeal pursuant to Rule 260 of the South Carolina Appellate Court Rules, and states as follows:

1. This appeal was dismissed for failure to provide the Notice of Appeal filing fee.
2. Appellant acted in good faith and paid \$50 believing that satisfied the filing requirement.
3. Appellant did not understand that a separate \$250 filing fee was required by the Court of Appeals and did not intend to delay or avoid payment.

AFFIDAVIT OF AARON E. QUINZY

I, Aaron E. Quinzy, being duly sworn, state as follows:
