**MOTION FOR EXTENSION OF TIME**

---

Respondent/Appellant Josee Riviere, by and through undersigned counsel, respectfully moves this Honorable Court for an Order granting a two-week extension of time to file her response in this appeal. This Motion is made pursuant to Rule 260(a), SCACR, and for good cause shown.<sup>1</sup> In support thereof, Josee Riviere states as follows:

1. This matter is presently pending before the South Carolina Court of Appeals under Appellate Case No. 2025-000150.

2. Respondent/Appellant Josee Riviere's response is currently due to be filed on February 2, 2026.

3. On or about January 26, 2026, counsel for Appellants/Respondents transmitted a filing to the Court that was later determined to be incomplete or incorrect.

4. Specifically, legal assistant Jaime Harmon notified the Court that the filing transmitted earlier that afternoon should not be accepted, stating:

“IF YOU COULD PLEASE FILE THIS ONE AND NOT THE ONE SENT AT 4:24 PM.”

5. Ms. Harmon promptly re-submitted the corrected filing with the proper attachments, including the Proof of Service for the Second Amended Record on Appeal.

6. The Court thereafter confirmed receipt of the corrected filing and provided a stamped copy for the parties' records.

7. The Proof of Service reflects that the Second Amended Record on Appeal was served by email on January 26, 2026, and certified on January 27, 2026.

8. Although the corrected filing was accepted, the initial erroneous submission and subsequent re-filing created uncertainty regarding the operative filing and service date for purposes of calculating the applicable response deadline under the South Carolina Appellate Court Rules.<sup>2</sup>

9. Respondent/Appellant Josee Riviere respectfully submits that a brief extension is necessary to ensure sufficient time to review the corrected record and to prepare an accurate and complete response.

10. This Motion is made in good faith and not for purposes of delay, and Respondent/Appellant requests only a modest extension of fourteen (14) days, making the response due date February 16, 2026.

WHEREFORE, Respondent/Appellant Josee Riviere respectfully requests that this Court grant a two-week extension of time, extending the deadline to February 16, 2026, and for such other and further relief as the Court deems just and proper.
