The Court's Order of January 21, 2026, states that "The Court is in receipt of the record on appeal and it has been filed. This appeal is no longer held in abeyance." Please note, however, that the appellant has not served a Record on Appeal on the respondent Holder Properties. Furthermore, it appears that no such record is available for download on the Court's C-Track website. Please also note that the only "Record" available (filed on September 30, 2025, and styled "Record on Appeal | University of South Carolina") contains only two documents out of 13 listed in Holder Properties, Inc.'s Designation of Matter to be Included in the Record on Appeal and is not paginated, which makes citations to the record impossible.

In light of the quickly approaching deadline for filing the final briefs, I would greatly appreciate the Court's guidance on the availability of a complete and properly paginated Record on Appeal in this case.
